1. Call to Order

- **Result:** Passed
- Anonymous posting has been disabled.

3. Enforcement of Out-of-Season Decorative Skeletons

- **Result:** Did not pass

4. Solar Panel By-Law Change

- **Result:** Did not pass
 - Solar panels remain **not permitted** in the community.

8. Animal, Pet, and Livestock Discussion

- Pets must remain on the owner's property or be on a leash in accordance with **Lexington County regulations**.
 - **Livestock is not permitted** per HOA by-laws.
 - All **reported animal violations** will be processed through **MJS**.

9. Community Updates

- New neighbors at the corner of **Shirway and Old Barnwell** will be **Midlands Landscaping**.
 - Midlands Landscaping provided goodie bags for attendees.
 - Midlands Landscaping is also the **current landscaping contractor** for the community.
